## **2010 - 2011 Calendar of Events**

**Blessing of the Vines - Saturday, November 13th** - Irvin House Vineyards, Wadmalaw Island. Set up begins at 11:00 and Show hours are 1pm to 5pm. This show is full. Booth fee is \$5.00 and will be collected the day of the event.

**Folly Beach Christmas Parade - Saturday, December 11th** - Folly River Park, Folly Beach. Show hours are 10 am to 4 pm. Set up begins at 8:00 am.

**Folly Gras Parade - Saturday, February 26th** - Folly River Park, Folly Beach. Show hours are 10:00 am to 4:00 pm. The sign up sheet will be available at the November meeting.

**Tides of March - Saturday March 19th and Sunday, March 20th.** Show hours are 10 am to 4 pm on Saturday and 1pm to 5 pm on Sunday. Set up starts at 8:00 on Saturday. We will have security, so you can leave your tents set up in the park overnight.

**Sea and Sand Festival - Saturday, April 16th.** We don't have any more information on this event as of yet. Booth fees and sign up have not yet been provided to the Guild by the Business Associations.

### **Show Rules:**

- Sign up sheets for upcoming shows are available at our monthly meetings. If you cannot make the meeting, and wish to attend a show, it is up to each individual member to notify the show organizer.
- Vendor booth spaces are available on a first come, first serve basis. The cut off for sign up to any show is the meeting before the upcoming show or when ever the 45 available spaces are taken, which ever comes first. After that, we will accept a waiting list and notify those individuals if a space become available.
- Vendors must be a member in good standing and have a current Folly Beach Business License.
- If you cannot make the show, you must give at least 24 hours notice or you will forfeit your booth space for the next show.
- Vendors must stay for the duration of the show. Those who leave early will forfeit their eligibility to participate in upcoming shows. Special circumstances can be arranged if we are notified well in advance of the event or in case of emergency.
- Spaces are assigned for each show. We try our best to rotate spaces for each show so that any one vendor is not in the same location every time. Maps with vendor locations are posted at the park and emailed to vendors at least 24 hours before the show.
- All vendors who sell in the Folly River Park must have a current City of Folly Beach business license.
